We have completed our review, and involvement activities in accordance with the Implementation Procedure for Design Approval between the FAA and Luftfahrt-Bundesamt (LBA). We assigned FAA project number SA11247IB-T to this activity.

The FAA finds the airplane additions to AML No. SA03898NY and the changes to the ORATEX Coating System acceptable and in compliance with STC SA03898NY. Our finding was based on the LBA validation application, reference number T314-ORATE/20 dated October 29, 2020 and LBA STC SA 1468 Revision 6 dated August 31, 2020.

Therefore under the terms of 14 CFR part 21.29, in accordance with the Implementation Procedure for Design Approval between the FAA and LBA, and LBA's statement of compliance dated January 27, 2022, we have amended STC SA03898NY, approved the enclosed AML No. SA03898NY and find the ORATEX Coating System as defined below,
